

Note: Unlike financial centers like ADGM, Masdar City Free Zone **does not currently offer Special Purpose Vehicles (SPVs)**. However, its FZ-LLC and branch office structures are robust and designed to support most commercial, service, and industrial activities.

For Entrepreneurs & Startups

1. Free Zone Limited Liability Company (FZ-LLC)

Ideal for: Startups, SMEs, and growing businesses seeking flexibility and autonomy.

- **Legal Status:** Separate legal entity
- **Shareholders:** Can be a single owner or multiple shareholders
- **Liability:** Limited to the share capital invested

Advantages:

- 100% foreign ownership
- Full repatriation of capital and profits
- Access to UAE markets through cluster partnerships

FZ-LLC is the **most common and versatile entity type** used in Masdar City Free Zone.

For Corporates & Global Companies

2. Branch Office

Ideal for: International companies seeking a physical presence in Abu Dhabi

- **Legal Status:** Legally connected to the parent company
- **Activities:** Must reflect the business scope of the parent company
- **Liability:** The parent company assumes full liability

Advantages:

- No minimum capital requirement
- Fast-track licensing and incorporation
- Full access to Masdar City's ecosystem while retaining global identity

The preferred route for **corporates testing the UAE market** or managing operations across the region.

3. Offshore Company

Ideal for: Companies that do not engage in commercial activity but want to promote or liaise for the parent entity.

- **Legal Status:** Extension of the parent company
- **Activities:** Marketing, liaison, R&D, and administrative functions only

While **Special Purpose Vehicles (SPVs)** are popular for investment structuring, **Masdar City Free Zone does not offer SPVs**.

For SPVs, entities may consider setting up in **ADGM**—which specializes in financial and holding structures under a common law framework.

Choose the Right License to Match Your Vision

Before launching your business in Masdar City Free Zone, it's essential to define what your business will do—and choose the appropriate license type. Masdar City Free Zone offers a flexible licensing framework covering a wide range of commercial, service, industrial, and freelance activities, all within a sustainability-driven ecosystem.

Licenses are typically categorized based on your business model, industry, and operational scope.

1. Commercial License

For companies engaged in **trading and commercial operations**, including import, export, distribution, and retail.

Examples of permitted activities:

- Import/export of sustainable goods
- Distribution of energy-efficient equipment
- Trading in smart tech, electronics, or eco-friendly materials

2. Service License

For businesses offering **professional, consulting, or technology services**. This is the most commonly used license type in Masdar City Free Zone.

Examples of permitted activities:

- Business consulting
- IT services and software development

- Engineering, design, and project management

Tip: Most startups and SMEs in Masdar City Free Zone start with a Service License.

3. Industrial License

For companies involved in light manufacturing, clean energy production, 3D printing, or R&D in industrial technologies.

Examples of permitted activities:

- Assembly of renewable energy components
- Fabrication of eco-friendly construction materials
- Smart device prototyping
- Sustainable packaging manufacturing

Industrial activity is subject to facility requirements and approvals from regulatory bodies.

4. Freelance Permit

For independent professionals offering their own expertise or creative services, with the flexibility of operating as a sole proprietor.

Examples of permitted activities:

- Marketing and content creation

- Photography, videography, and media

Freelance permits may have restrictions on hiring employees and are issued under specific activity codes.

Setting up your company in Masdar City Free Zone is designed to be streamlined, digital, and founder-friendly. Whether you're an entrepreneur or an established corporate, the process can take as little as 5–10 working days if your documents are in order.

Here's your step-by-step guide to setting up a business in Masdar City Free Zone.

Step 1: Pre-Registration Essentials

Before applying, take time to align your business concept with Masdar City's ecosystem.

1. Business Feasibility & Market Fit

- Refine your business plan or concept
- Ensure your proposed activity is aligned with Masdar City Free Zone's permitted sectors
- Choose your legal structure (FZ-LLC, Branch Office, Sole Establishment)

2. Choose Your Business Activity & License Type

- Match your offerings to the correct license (Commercial, Service, Industrial, Freelance)

3. Select a Company Name

- Must not conflict with UAE naming guidelines (no offensive terms, no religious references, etc.)
- Should reflect your actual business activity
- Can be in English or Arabic (with translation)

4. Choose an Office Space

Options include:

- Flexi Desk – For startups, freelancers, or remote-friendly operations
- Private Office – For small teams or client-facing firms
- Custom Facility – For industrial or R&D activities

Step 2: Submit Your Application

All applications are processed through a registered agent and the Masdar City Free Zone portal.

Documents typically required:

- Passport copies of all shareholders and managers
- Passport-size photos
- Proposed trade name (3 options)
- Summary of business activities
- Business plan or feasibility report (for certain sectors – template provided by MCFZ)

- MOA & AOA (Memorandum & Articles of Association– template provided by MCFZ)
- Lease agreement or letter of intent

Step 3: Government Review & Approvals

Once your documents are submitted:

- Masdar City Free Zone Authority conducts due diligence and regulatory checks
- You may be asked for clarifications or additional details
- For sensitive activities (e.g., AI, media, fintech), approvals may also involve VARA, Media Council, ADGM, ADAFZ, or other cluster partners

Step 4: License Issuance & Company Incorporation

Once approved, you'll receive:

- Trade License (valid for 1–3 years depending on package)
- Certificate of Incorporation
- Lease Agreement for your office or desk space
- Establishment Card (required only if you need visas)

Congratulations—your business is now legally registered in Masdar City Free Zone!

Step 5: Visa & Immigration Setup (Optional)

- If you are hiring staff, register with the relevant authorities
- Apply for Visas as per your quota
- Open your corporate bank account
- Finalize labour contracts, health insurance, and Emirates ID processing

Setting up in Masdar City Free Zone means operating in a business-friendly jurisdiction backed by **transparent laws, progressive policies, and a strong regulatory ecosystem**. Whether you're a founder new to the UAE or a multinational entering the market, here's what you need to know about legal and compliance obligations.

10.1 Key Regulatory Bodies & Legal Framework

Masdar City Free Zone Authority (MCFZA)

- Primary licensing and regulatory body
- Oversees registration, renewals, office leasing, and visa services
- Enforces sustainability standards and environmental compliance within the zone

UAE Commercial Companies Law (CCL)

- Applies where relevant for corporate governance, especially if you operate outside the free zone or set up a mainland branch later
- ATB Legal advises on when CCL applies to dual-licensed or hybrid entities

Environmental, Social, and Governance (ESG) Compliance

- Masdar City mandates sustainable practices as part of its operating ethos
- Businesses may be required to report energy use, emissions, and waste reduction metrics

- Compliance with **Estidama** and **LEED** standards is often necessary for building and operational approvals

10.2 Taxation & Financial Reporting

Corporate Tax (UAE 2023 Law)

- **0% corporate tax** on qualifying income earned within the free zone
- Businesses with mainland operations or exceeding AED 375,000 in non-qualifying revenue may be subject to 9% federal tax
- Masdar City entities must demonstrate **“substance” and economic activity** to maintain free zone tax benefits

VAT (Value Added Tax)

- VAT at 5% applies if your taxable turnover exceeds AED 375,000/year
- Registration with the **Federal Tax Authority (FTA)** is mandatory
- Quarterly VAT returns and record-keeping are legally required

Financial Reporting & Audit

- Most Masdar City Free Zone entities must maintain **audited annual financial statements**
- Bookkeeping must follow **International Financial Reporting Standards (IFRS)**
- Some businesses (especially industrial or service sectors) may be exempt in early years
- We recommend professional accounting support to stay audit-ready and maintain free zone tax eligibility.

10.3 Employment & Labour Compliance

Employee Visa Sponsorship

- Businesses must register for an **establishment card** and **e-channel system** to sponsor staff
- Employment visas and dependent visas are available through Masdar City Free Zone
- Medical tests, Emirates ID, and health insurance are mandatory for visa issuance

Labour Contracts & MOHRE Alignment

- Employees must be issued **UAE-compliant labour contracts**

 - Probation periods
 - End-of-service benefits

10.4 Data Protection & Intellectual Property (IP)

Data Protection

- Businesses handling personal data must comply with **UAE Data Protection Law (Federal Law No. 45 of 2021)**
- Security measures, breach reporting, and client consent are critical in digital businesses
- Cloud-based companies may also require compliance with international standards like GDPR

Intellectual Property (IP)

- Trademarks, patents, and designs can be registered with the **UAE Ministry of Economy**
- Masdar City Free Zone encourages businesses to protect innovations, especially in:

 - Industrial designs & prototypes

We've gathered the most frequently asked questions from entrepreneurs, SMEs, and global corporates considering Masdar City Free Zone as their UAE base. Here's what you need to know.

1. How long does it take to set up a company in Masdar City Free Zone?

Typical time: 5–10 working days, if documents are in order.

Add 5–7 more working days for visa processing, establishment card, and immigration clearance.

2. Do I need to be in the UAE to register my company?

No, you can set up remotely via Masdar City Free Zone's digital portal or through a registered legal advisor. However, **your physical presence is required** for visa processing and Emirates ID registration later.

3. Can I operate outside Masdar City Free Zone with a free zone license?

Yes—you can export services and products internationally.

To do direct business in UAE mainland (outside the free zone), you'll need:

- A mainland branch OR
- A local distributor / service agent OR
- A dual license in some cases (subject to approvals)





4. What is the minimum capital requirement to open a company in Masdar City Free Zone?

There's **no mandatory minimum capital deposit**.

However, a nominal capital value (often AED 10,000–50,000) must be declared in your Memorandum of Association (MoA) for legal purposes. **T&C applies. Depending on the activity chosen, the capital requirement may increase.**

5. Are visas included in the company setup package?

Only **Business One** and **Enterprise** packages include **visa quotas**:

- **Business One:** 1 visa quota
- **Enterprise:** 3 visa quota

Additional visa quotas can be added based on your office space and business type.

Business One package includes visa costs, whereas, **Enterprise** packages include only a visa quota; visa charges will be charged at actuals.

6. Can I apply for a freelance license in Masdar City Free Zone?

Yes—**freelance permits are available** for certain professional categories such as:

- Media & content creators
- Consultants

- Developers & digital professionals

Freelancers operate under their own name and cannot hire staff.

7. Can I own more than one business in Masdar City Free Zone?

Yes, you can hold multiple licenses under the same ownership.

Each entity will require separate registration and trade license, but you can centralize operations in one office (if activity scope allows).

8. Is Masdar City Free Zone only for sustainability-related businesses?

No. While sustainability is a central theme, Masdar City Free Zone welcomes businesses across sectors like:

- Technology
- Consulting & advisory
- Media & marketing
- Education
- Fintech
- Urban innovation

As long as your operations align with the city's **low-impact, smart infrastructure model**, you're welcome.

9. What banks can I open a corporate account with?

Masdar City Free Zone is recognized by all major UAE banks, including:

- First Abu Dhabi Bank (FAB)
- Emirates NBD
- ADIB
- RAKBank
- HSBC

Account approval depends on your business activity, shareholders, and country of origin.

10. What ongoing compliance obligations do I have?

- Annual license renewal
- Audited financials (if applicable)
- VAT registration and filing (if threshold crossed)
- Employee visa renewals
- Sustainability or ESG reporting (for some sectors)


